No appeals may be submitted against the ruling.

If the ruling, the procedure that serves as its basis or the documents that serve as the attachment to the ruling are unlawful then the prosecutor or the person subject to the ruling may initiate a lawsuit – regarding the part of the ruling that they are subjected to – against the organisation regarding the repeal of the ruling at the competent court based on the headquarters of the organisation. The lawsuit may be filed within 60 days of the current ruling being recorded in the national registry. The deadline includes a limitation period.

## PREAMBLE

The founder requested the simplified registration procedure through a submission via their representative on the 2<sup>nd</sup> of July 2018.

The Court determined that the documents provided by the claimant adhere to the contents of sections 3:378. – 3:404. of Act V of 2013 of the Civil Code, Act CLXXXV of 2011 (referred to henceforth as Ectv.) on the right of association, charitable status, and the operation and support of non-governmental organisations, and Act CLXXXI. of 2011 (referred to henceforth as Cet.) on the registry of non-governmental organisations and related procedure regulations. Because of this, based on paragraph (1) of section 30. of Cet., the court made the ruling detailed in the operative part.

Appeals are ruled out based on paragraph (1) of section 46/A. of the Cnytv. Information regarding the lawsuit is based on paragraph (1) and (2) of section 46/A. of Cnytv. The ruling will be published on [www.birosz.hu](http://www.birosz.hu) to the national registry of non-governmental organisations.
